**SAN MATEO COUNTY COMMUNITY LAW NIGHT COMES TO
SOUTH SAN FRANCISCO COURTHOUSE**

Presiding Judge George A. Miram announced today that on Thursday, September 14, 2006 the San Mateo County Superior Court, the San Mateo County Bar Association and the San Mateo County Board of Supervisors are sponsoring a free of charge Community Law Night in the South San Francisco Courthouse located at 1050 Mission Road from 5:30 to 8:30 p.m.

The mission of Community Law Night is to assist and educate San Mateo County residents regarding their legal issues by providing free informational lectures, one-on-one attorney consultations and information about available community resources.

The event consists of three components

- Fifteen minute mini-consultations with over 50 volunteer attorneys**
- A legal resource program with representatives from government agencies and non-profit organizations**
- Lectures on “Family Law” and “How to Represent Yourself in Court” in English, Spanish and Tagalog**

Attorneys will also be available for a limited number of mini-consultations after the lectures. These will be conducted in English with interpreters (Spanish, Tagalog, Visayan-Hiligaynon and other dialects).

Attorneys are prepared to discuss various topics such as, immigration, adoption, guardianship, elder law, real estate, bankruptcy, divorce, DUI, criminal, juvenile and adult felony misdemeanor related questions.

Participation is on a first come, first served basis and FREE childcare will be available.
