REVISED ORDER ASSIGNING DUTIES OF THE JUDGES
OF THE COURT JANUARY 1, 2018 TO DECEMBER 31, 2018

IT IS HEREBY ORDERED FOR THE YEAR BEGINNING JANUARY 1, 2018 THAT THE FOLLOWING ASSIGNMENTS SHALL BE FILLED BY THE JUDGES AND COMMISSIONERS OF THE ABOVE-ENTITLED COURT, SUBJECT TO SUCH CHANGES AS MAY LATER BE MADE BY THE PRESIDING JUDGE:

I. COURT ADMINISTRATION

PRESIDING JUDGE

HON. SUSAN IRENE ETEZADI shall act as **Presiding Judge** and shall perform all the duties prescribed for the Presiding Judge by the California Rules of Court and the rules of this Court as amended.

ASSISTANT PRESIDING JUDGE

HON. JONATHAN E. KARESH shall act as **Assistant Presiding Judge** and perform administrative duties as assigned by the Presiding Judge including serving as Presiding Judge.

SUPERVISING JUDGES

HON. MARIE S. WEINER shall act as **Supervising Judge of Civil, Case Management and ADR Programs** and perform administrative duties as assigned by the Presiding Judge and the Assistant Presiding Judge.

HON. JONATHAN E. KARESH shall act as **Supervising Judge of Commissioners and Judge Pro Tems** and perform administrative duties as assigned by the Presiding Judge.

HON. LELAND DAVIS, III shall act as **Supervising Judge of Criminal** and perform administrative duties as assigned by the Presiding Judge and the Assistant Presiding Judge.

HON. SUSAN L. GREENBERG shall act as **Supervising Judge of Family Law** and perform all administrative duties as assigned by the Presiding Judge and Assistant Presiding Judge.

HON. JEFFREY R. FINIGAN shall act as **Supervising Judge of the Northern Branch Court** and perform all administrative duties as assigned by the Presiding Judge and Assistant Presiding Judge.

HON. ELIZABETH K. LEE shall act as the **Supervising Judge of the Juvenile Court** and perform all administrative duties as assigned by the Presiding Judge and Assistant Presiding Judge.

II. SPECIALTY ASSIGNMENTS

CRIMINAL PRESIDING JUDGE

HON. STEPHANIE G. GARRATT shall act as Criminal Presiding Judge with primary responsibility for the Master Criminal Calendar and the Superior Court Review Program.

JUVENILE JUDGES

HON. ELIZABETH K. LEE and HON. MARTA S. DIAZ shall act as Juvenile Court Judges.

FAMILY LAW

HON. DON R. FRANCHI, HON. SEAN P. DABEL AND HON. ELIZABETH M. HILL are assigned to act as Family Law Judges and will handle Family Law cases.

BRIDGES PROGRAM JUDGES

HON. MARK R. FORCUM is assigned to act as Admitting Judge and Review Judge for the Bridges Program and HON. JONATHAN E. KARESH is assigned as Review Judge for the Bridges Program.

DRUG COURT-PROPOSITION 36 JUDGE
